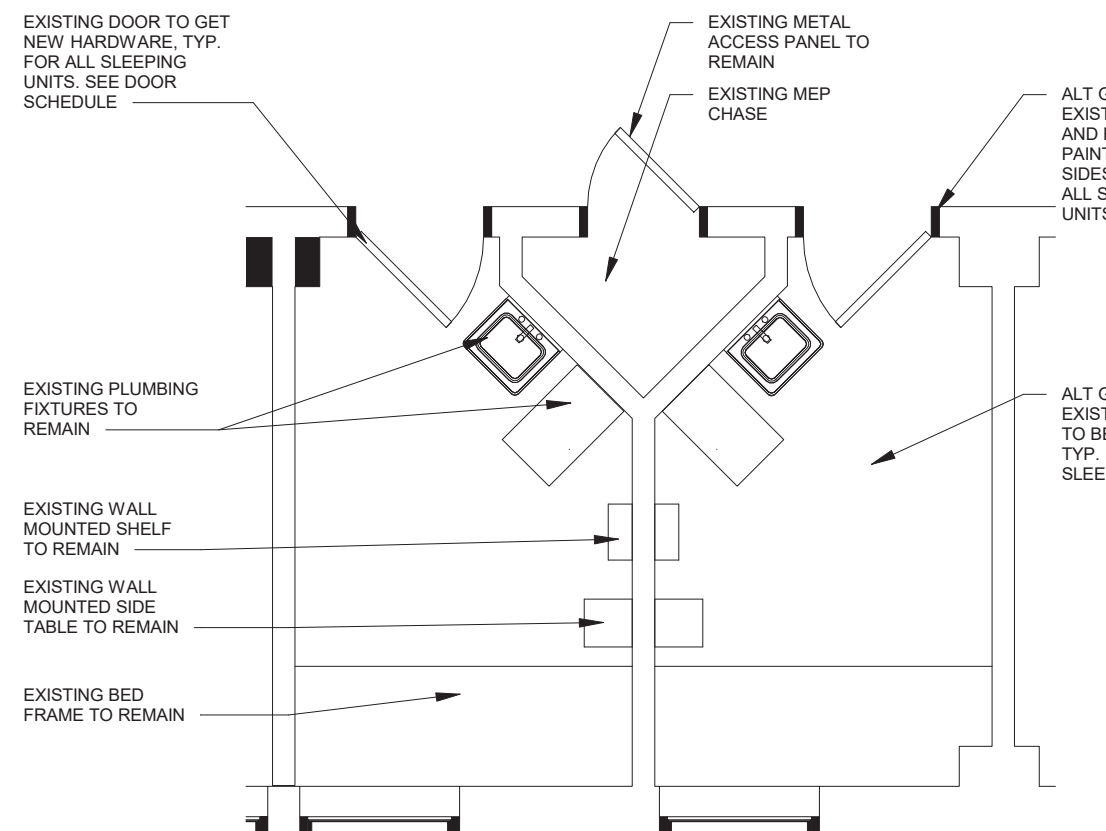
1 SECOND FLOOR PLAN - NEW ARCHITECTURAL WORK

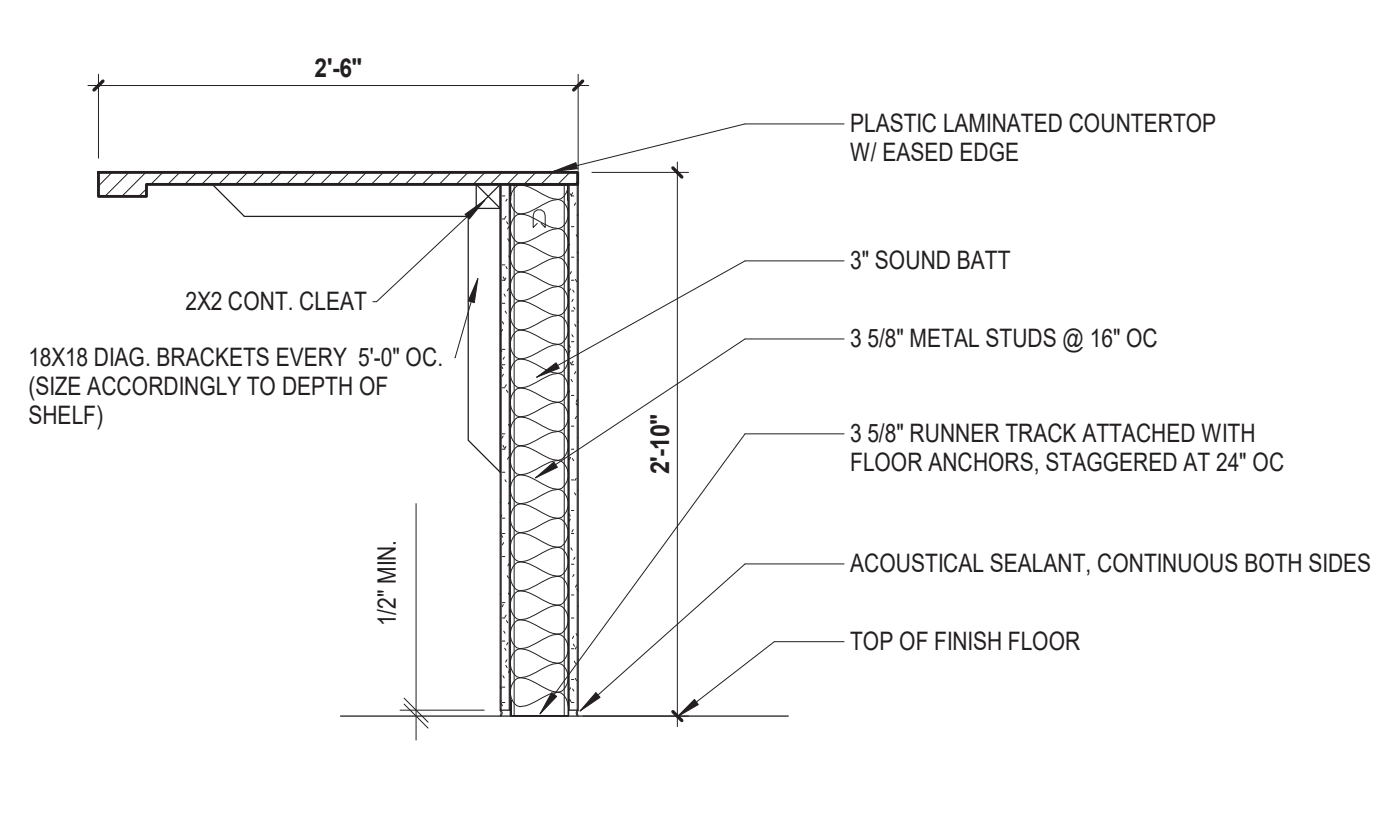
2 SECOND FLOOR - TYP. WASHER/DRYER

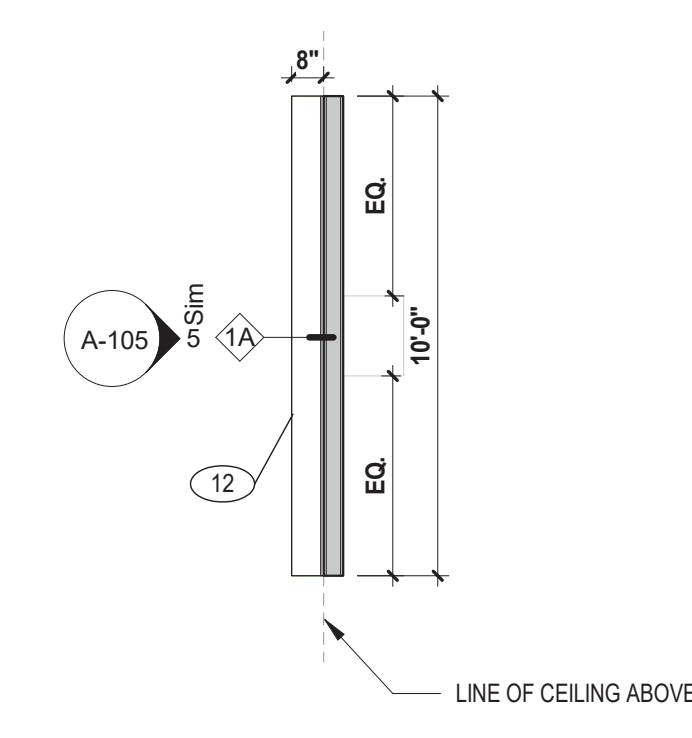
4 WASHER & DRYER ELEVATION

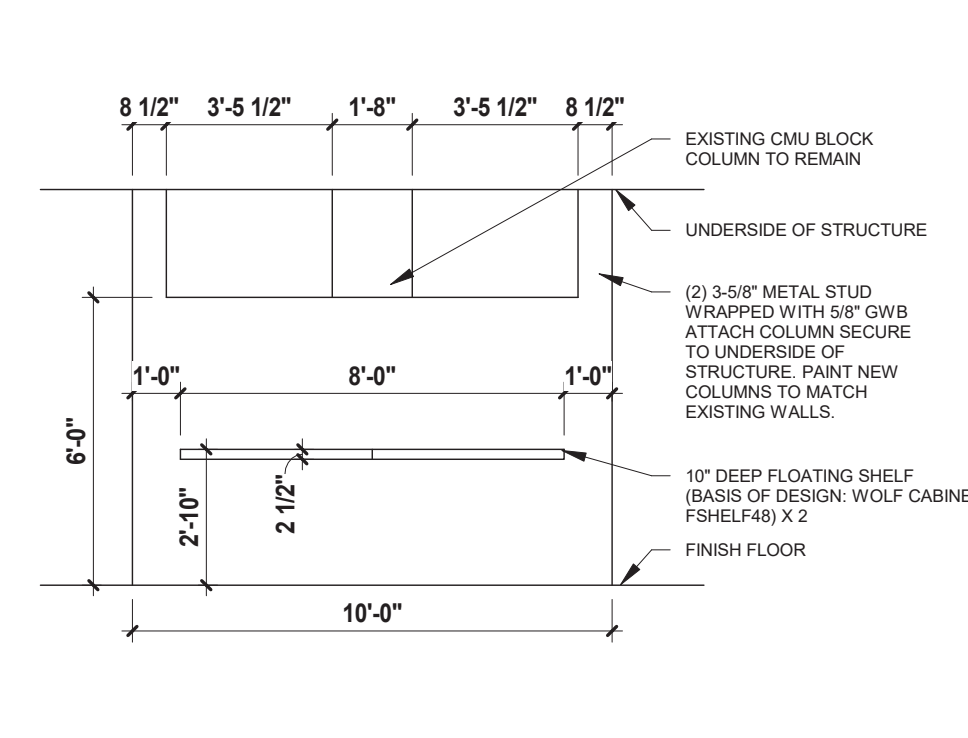
6 ENLARGED SLEEPING UNIT, TYP.

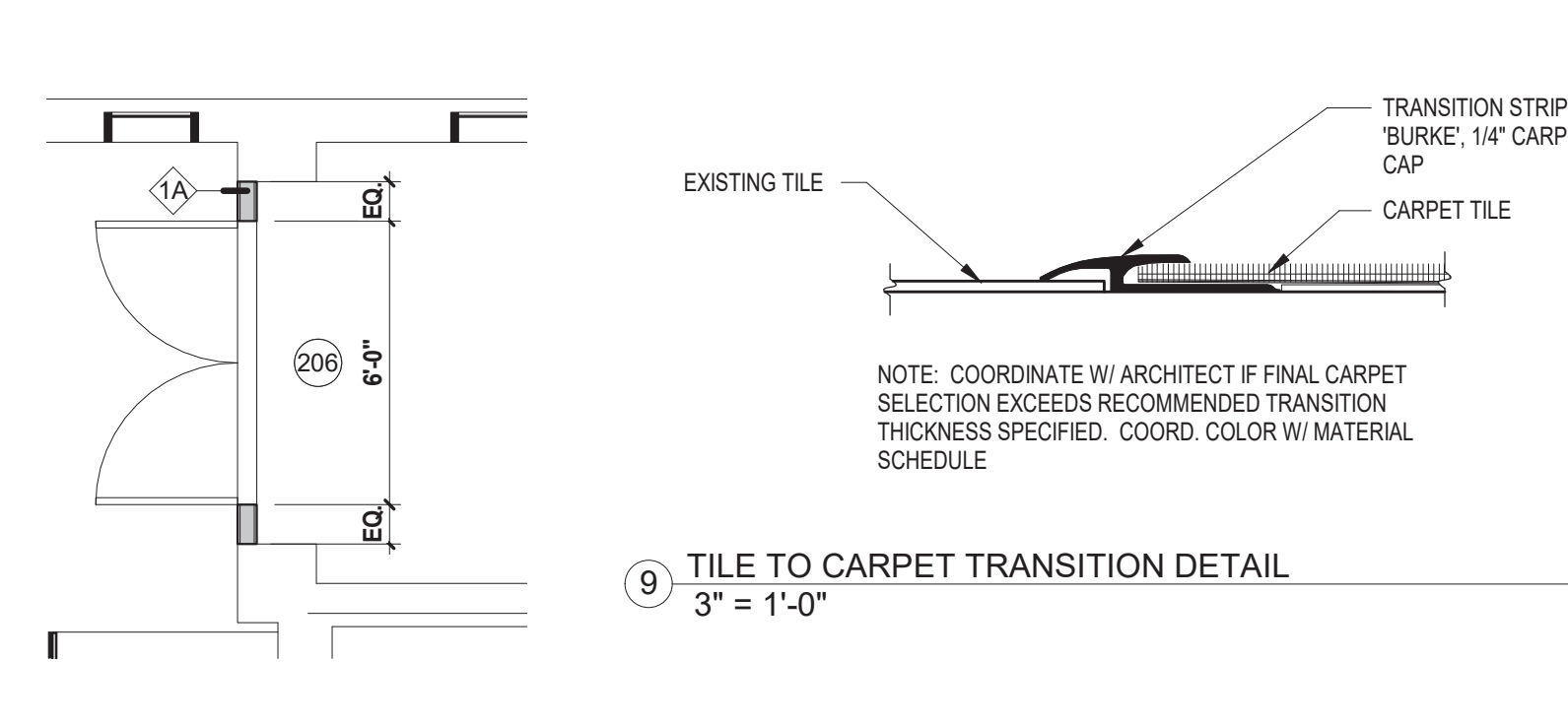

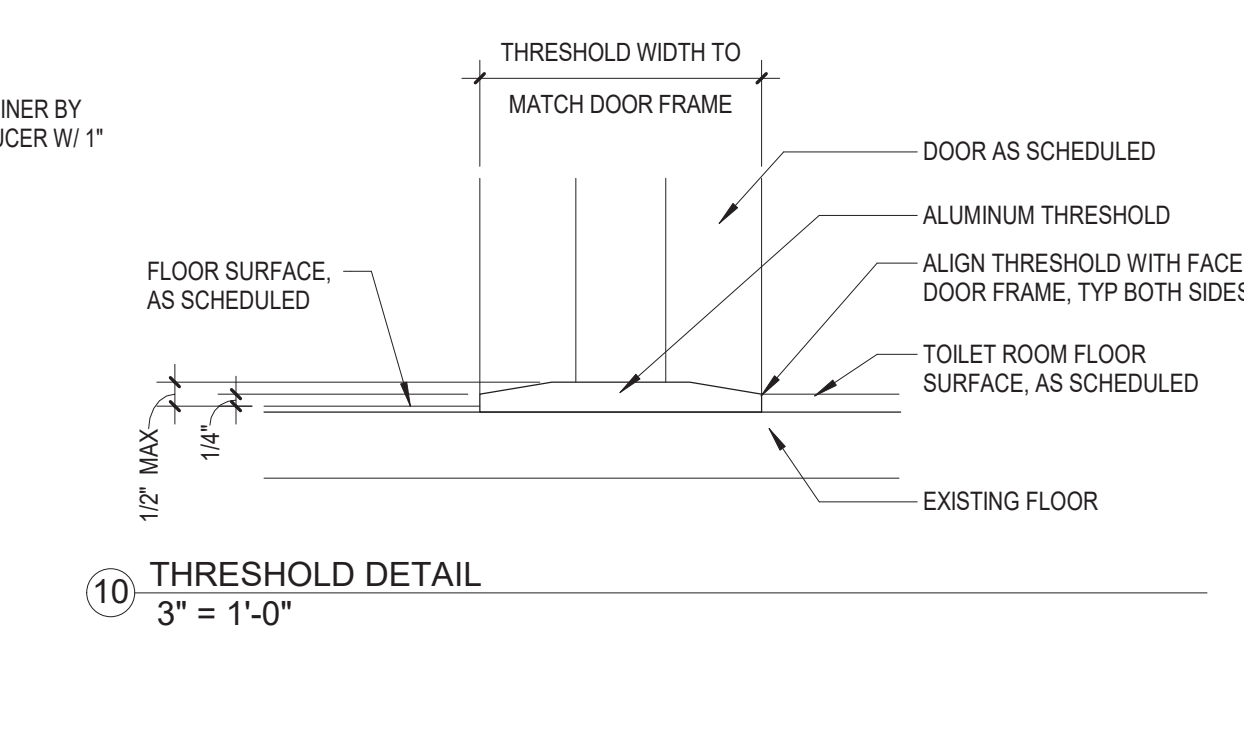

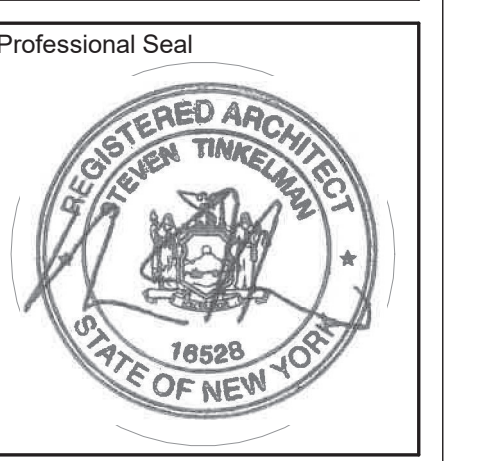
