RFI: At the pre-bid meeting it was confirmed that this is a prevailing wage project but the bid documents are asking for statement of the contractor's apprenticeship program compliance form to be executed. Said form is asking the bidder to sign off on an agreement to enforce apprenticeship programs for the work on this project, which makes the project a PLA project. Please advise

YJSCB RESPONSE: Confirming this project is a Prevailing Wage Project. See attached 004200 removing language that refers to a Project labor Agreement. Any other references to a Project Labor Agreement (PLA) in the Documents shall be disregarded.

11. RFI: Drawing P200 shows 4" horizontal gas piping to Domestic Hot Water heater. Please provide sizing of the gas pipe drop to hot water heater along with gas pressure regulator size.

YJSCB RESPONSE: Gas drop size 4", regulator sized to meet manufacturer's required pressure at heater.

**12. RFI:** Please confirm the bid bond is to be in the form of AIA 310. Typically, the City of Yonkers has their own bid bond forms.

YJSCB RESPONSE: Confirming AIA 310 shall be used as the Bid Bond Form. See attachment.

**13. RFI:** Stage Floor Finish WD on Drawing A507; Detail NB Drawing A812 Built-Up Wood Flooring and SN on Drawing A706, which spec section for Stage Flooring?

YJSCB RESPONSE: Clarification - The stage stair shown on Drawing A706 Sn is the back stage stair. The gym floor and stage floor shall be the same wood flooring. Both areas to be built as per the Wood Athletic Specification section 096466. The main stage steps shall be a Maple treads/riser- 5/4 x4 maple with half round bullnose edge with 1" overhang matching the stage and gym floor in color. The edge of the stair tread should also have a 1" epoxy black grit channel strip along the entire length to create a visual distinction between steps. A 6"h vented cove black rubber base, coiled lengths, is required on the perimeter of the entire wood floor- stage and gym area typ.

**14. RFI:** RB Rubber Base at Landings / Platforms; please indicate which Drawing shows limits/locations of RB on walls for Landings / Platforms.

YJSCB RESPONSE: At stairs the only limit are the stair stringers which are on the run of stairs, intermediate landings and where the railing returns to the wall. All other areas landings/entries to stairs require a rubber base.

- **15. RFI:** Room 214 Drawing A502 shows LVT-1, Drawing A506 calls for LVT1, LVT2, please clarify. **YJSCB RESPONSE:** Room 214 is LVT1 only.
- **16. RFI:** Detail GN Drawing A706; Top Tread is Rubber or Terrazzo?

YJSCB RESPONSE: Rubber which should align with edge of turning stringer, coordination is required for a flush transition.

**17. RFI:** Top Step Nose at Landings/Platforms; cut down a tread to butt flush with 3.5mm Rubber Tile or use a prefabricated Step Nose, similar to Nora T5044 E/F or T5049 E/F?

YJSCB RESPONSE: Cut down the one piece tread portion of the unit.

18. RFI: Please confirm No Rubber Tread/Riser required in Stair F; Dawning A705.

YJSCB RESPONSE: Stair F to be concrete filled pan similar to A708, detail 3 but with a 3"stainless steel slip resistant profile edge.

19. RFI: Stair B Steps are approx 78" wide, Nora Treads are maximum 72" wide, Please let us know how to proceed with this bid scope.

YJSCB RESPONSE: Provide Specified Grano and Satura rubber in the available 78.89 width, typ.

**20. RFI:** Lobby C101 on Drawing A506 indicates partial RB Rubber Base, please point us to RB location, do not see RB on Drawing A411?

YJSCB RESPONSE: C101 to have a 6"h terrazzo base matching the adjacent terrazzo base, there is no rubber base in these areas.

- **21. RFI:** Corr C104 on Drawing A506 indicates partial RB Rubber Base, please point us to RB location, do not see RB on Drawing A814?
  - YJSCB RESPONSE: C104 to have a 6"h terrazzo base matching the adjacent terrazzo base, there is no rubber base in these areas.
- 22. RFI: Stair SC3 3rd Floor Drawing A506 calls for T-1 / TRB-1, might that be RT / RB? YJSCB RESPONSE: Correct. SC3 is RT and RB not terrazzo.
- 23. RFI: We have not seen a bidders qualification statement on an AIA required for submission at bid before. Does this in fact need to be submitted with the bid? If so, am I supposed to fill it out on the AIA A305 form provided in the bid documents? That one has "draft" written on each of its pages so I am unclear on whether or not that is the one to be used. Also it need exhibits A-E filled out in their entirety?
  YJSCB RESPONSE: Bidders qualification forms AIA A305 and associated Exhibits A-E shall be included with the bid. See attachments for AIA forms without the "DRAFT" watermark.
- 24. RFI: Drawings indicate refrigerant piping. Refrigerant piping sizes are needed. Please provide. YJSCB RESPONSE: Refrigerant pipe sizes are by the VRF or heat pump system manufacturer. See the pipe size reference note on each sheet.
- 25. RFI: Drawing H-300 indicates for Basement Floor Mechanical Piping on the lower part of the drawing a scale of 1/8"=1'-0". Is this correct?
  - YJSCB RESPONSE: The referenced scale shall read 1/4"=1'-0".
- 26. RFI: Please confirm for Plumbing contract the alternate bid scope is the work shown ONLY on drawing p213 for anything above ground.
  YJSCB RESPONSE: Everything on P211 is Base Bid. All work shown on P213 that is not on P211 is the
  - alternate.
- 27. RFI: Please provide a list of manufacturers and spec sections for the 2 fences shown on A309 (Decorative fence and Metal fence).YJSCB RESPONSE: Fence information for Decorative fence and Metal fence on A309 is provided in Section
  - YJSCB RESPONSE: Fence information for Decorative fence and Metal fence on A309 is provided in Section 323119 (Ornamental steel perforated metal panel fencing, Ornamental steel picket metal fencing, etc.).
- 28. CLARIFICATION: Stairwell wall mounted lights shall be mounted at height of 7'-0" AFF in lieu of 6'-0" AFF. Contractor(s) shall confirm with Architect in field prior to installation of wall mounted lighting.
- 29. CLARIFICATION: Detail D/A708 indicates a "Continuous 1/8" thick steel plate, scribe to wall, weld to stringer with steel cove moulding similar to J.Blum #6952 (typ. Stair and landing stringers)". This steel plate and cove moulding shall be provided continuously at ALL interior stair locations where the steel stair stringer is against/parallel to a wall.
- 30. CLARIFICATION: AIA Documents that are not included in this Addendum, and are marked with the "DRAFT" watermark, are to be considered as final documents, not draft documents. These forms include, but not limited to, AIA A132 Standard Form of Agreement Between Owner and Contractor, A232 General Conditions of the Contract for Construction, A312 Performance Bond and A312 Payment Bond.

CLARIFICATION: Site conditions at the project site at the beginning of this Contract will include the following elements left remaining following the Demolition Contract: erosion controls; stabilized construction entrances; perimeter construction fencing; complete demolition and removal of the preexisting buildings including foundations and footings; temporary field office and restroom trailers; active sanitary, water and electric utility connections at project trailers; excavation and grading to approximate subgrade elevations; site modifications and removals within the property boundaries; site stabilization and protection of existing adjacent properties including protective scaffolding at two sides of the Church. The General Contractor shall acquire responsibility for same upon start of work, including financial responsibility, and shall remove all temporary elements at completion of the work.
